### EMPLOYMENT NOTICE

Applications are invited for 04 posts (Genl.-01, Deprived SC-01, BCA-01, EWS-01) of Lift Operator for Judicial Courts Complex, Nuh for the financial year 2026-2027 i.e., upto 28.02.2027 on contract basis at the rates fixed by Haryana Kaushal Rozgar Nigam from time to time. In case of non-availability of candidates belonging to reserved category, then the posts may be filled up from amongst the candidates available in unreserved category. The candidates should have attained the age of 18 years and should not be more than 42 years, as on 01.01.2026. Relaxation in upper age limit as per rules. The candidates must possess the following qualifications:

1. Matric with Hindi or Sanskrit from a recognized Board.
2. I.T.I Trade Certificate in Electrician from any Govt. Institute or its equivalent.
3. 02 years experience in the operation and maintenance of lifts.

The applications be submitted on plain paper giving complete particulars in the format i.e. Name of the post applied for; Full name of the candidate; Father's name; Date of birth; Sex, Educational qualifications; Category of reservation (mandatory), if any; Present postal address with contact number; Permanent address; Experience, and other particulars duly supported by self attested copies of testimonials and documents. One duly self attested passport size photograph be pasted on the application form. The application form complete in all respect should reach this office on or before 06.04.2026 by 5:00 P.M. Applications filled in incompletely, without photograph and without copies of relevant certificates, shall be rejected straightaway without any information to the candidates. No correspondence, whatsoever, will be entertained in respect of incomplete applications or the applications received after the last date. This office shall not be responsible for late receipt/non-receipt of application form due to the lapse of Postal Department. If at a later stage, any information furnished by the applicant is found false, his/her candidature/selection shall be liable to be cancelled.
